#### Overview of Benefit Corporations

#### 1. Not a non-profit corporation

- Existence of Shareholders
- For -profit motive
- Not a public charity
- Not tax exempt



# 2. Differences from other for-profit corporations

- Organized and administered for much more than for-profit motives, much more than just return for shareholders
- Organized to also benefit employees
- Organized to also benefit environment
- Organized to also benefit community
- Accountability for acting in all interests, for which B corporation was formed

### 3. B Corps In Massachusetts

- Statutory benefit corporations since 12/1/2012, under Mass. Gen. Laws chapter 156E
- LLCs, partnerships as non-statutory "certified B corps"

#### 4. Global Movement

- People using business as a force for good тм
- Verified Social and Environmental performance

Public transparency



### Statutory Benefit Corporations under Mass. Law 1. Incorporation under MGL ch. 156E

- Only Massachusetts corporations
- Compliance with either 156A (professional corporations) or 156D (business corporations)
- Added terms that create benefit corporation
- Shareholder agreement to those terms

2. Key components of Mass. benefit corporation

- Independent Benefit Director
- Benefit Officer



#### 3. Changing to 156E corporation



- Change by existing corporations to benefit corporations
- Mergers to form benefit corporations

### 4. Annual Reporting

- Annual report filed with State
- Annual report to shareholders
- Meeting third party standard

#### 5. Enforcement

- Advertising as a B Corporation
- Limited liabilities of officers/directors
- Termination of status

#### Certified B Corps - worldwide private certification

#### 1. B Lab & its certification process

- B Lab is a non-profit organization
- Building global community of certified B corporations
- Align interests of business and society
- Measure and monitor societal impact

#### 2. Eligible businesses

- LLCs, partnerships & sole proprietors eligible to be B corps if meet certain standards
- All benefit corporations are eligible to be certified B corps

#### 3. Requirements for certification

- Taking the B Impact Assessment
- Assessment Review and Submit Supporting Documentation
- Disclosure questionnaire and Background checks

#### 4. Maintaining certification

- Re-certification every 2 years
- Update to assure the B corp continues to engage in a high level of impact with their stakeholders

#### 5. Worldwide movement

- Over 1,500 certified B corps, in over 30 countries
